



**PLAN OF DISSOLUTION
OF
CAROLINA THREAD TRAIL
(the “Corporation”)**

1. Upon the approval of the dissolution of the Corporation by the Board of Directors of the Corporation, the plan of dissolution set forth below shall be implemented to effect the liquidation of the Corporation.
2. The proper Officers of the Corporation shall sell or otherwise liquidate any and all of the assets of the Corporation which in their judgment should be sold or liquidated to facilitate the liquidation of the Corporation, and shall execute deeds, bills of sale, and other documents that may be necessary or appropriate to effect such sale and liquidation.
3. The proper Officers of the Corporation shall file any and all necessary or appropriate documents of dissolution and liquidation with federal, state and local authorities, including, but not limited to, Articles of Dissolution with the North Carolina Secretary of State pursuant to Section 55A-14-04 of the North Carolina Nonprofit Corporation Act and appropriate forms with the Internal Revenue Service reporting the dissolution, as applicable.
4. After all of the Corporation’s liabilities and obligations have been paid or discharged or adequate provision made therefor, the proper Officers of the Corporation are hereby directed to distribute the remainder of the Corporation’s assets as follows:
 - a. Any assets held by the Corporation upon condition requiring return, transfer, or conveyance, which condition occurs by reason of the dissolution, shall be returned, transferred, or conveyed in accordance with such requirements.
 - b. Any endowed assets held by the Corporation at the Foundation For The Carolinas shall remain in an endowed fund at the Foundation For the Carolinas for the benefit of the Catawba Lands Conservancy and to be used for the purposes of creating or maintaining greenways, trails, parks, recreation areas, or other open natural or civic spaces, with a goal towards preserving natural areas or other purposes.
 - c. All of the remaining assets of the Corporation, including any non-endowed funds held at the Foundation For The Carolinas, shall be distributed to Catawba Lands Conservancy in Charlotte, North Carolina, provided that such organization is in existence, is organized and operated exclusively for one or more exempt purposes specified in Section 501(c)(3) of the Internal Revenue Code, as amended (the “Code”), and qualifies as an organization described in Sections 501(c)(3) and 170(c)(2) of the Code.
5. The proper Officers of the Corporation shall take actions necessary for the complete liquidation of the Corporation, and the distribution of the Corporation’s assets shall be commenced as soon as practicable, and such assets shall be distributed and the liquidation completed as soon as reasonably practicable.
6. If deemed appropriate, the proper Officers of the Corporation shall notify all known claimants in writing of the dissolution in accordance with and pursuant to Section 55A-14-07 of the North Carolina Nonprofit Corporation Act; and if deemed necessary and appropriate, the proper Officers

of the Corporation shall notify all unknown claimants by publishing notice in accordance with and pursuant to Section 55A-14-08 of the North Carolina Nonprofit Corporation Act.

7. The proper Officers of the Corporation shall pay all such fees and taxes and do or cause to be done such other acts and things as they may deem necessary or proper in order to carry out the liquidation and dissolution of the Corporation.
